

The NFRW Advocacy Training Committee is one of a handful of special committees assembled by your NFRW President, Julie Harris. Our mission is to prepare information for NFRW leadership on given topics. The Chair of this 12-woman group is none other than our former three-time COFRW President, Deborah Tilden, now of Montana. Jann Hopkins is a committee member and formerly COFRW Secretary and Achievement Awards Chair. Jann and her husband now reside in Florida. I am Margie Crawford, your current newsletter editor and webmaster, and now the Secretary of this committee. COFRW is well represented at this national level. Other women in the group are residents of Arizona, Indiana, Louisiana, Kansas, Arkansas, and Wisconsin. The group includes

women who are lawyers, judges, and State NFRW Presidents. We meet every week by Zoom at this point.

In May, we had an amazing list of speakers including Clare Lopez, Founder of Lopez Liberty, LLC, Christie Hutcherson, Women Fighting for America, J.J. Carroll, retired 24-year Border Patrol Agent and author of *Invaded*, and our very own member and Oregon State Representative, Vikki Breese-Iverson, reporting about her recent trip to the Yuma Sector of the US Southern Border.

The topics that we originally were assigned included human trafficking, women's health and the Border crisis. Honestly, the latter has dominated our conversation and includes the other topics. Our federal government has failed to protect us at the Southern Border, yes, but also the Northern Border, East and West Coasts, and the fifth

border – Digital.

A couple of tasks we are developing:

- A 30-minute video presentation in July on the Border for NFRW.
- A 10-point list of questions for members to use when interviewing candidates.
- A To-Do list for members like “Know your Sheriff”; understand the extent of human trafficking, sex trafficking, drug use, military threat, etc. caused by the millions of illegal aliens in our country; tools on how to reach your Legislators with questions.

I will report to you each month in person at our luncheon meetings or by newsletter.

## In Memoriam: Martin Andrew Smith

Memorial Day is the 27th of May this year. We will all remember friends and relatives who are no longer with us. This year, I add another lovely person to my memories: Martin Andrew Smith. He passed away in late April, my son-in-law Jeremy's grandfather. My husband and I attended his funeral and joined others as we listened to Jeremy and his father, Randy, speak of him. Randy eloquently told us of losing his own father at the age of 12. Later, Marty became the father figure that Randy had missed out on. He married Marty's daughter, Patti. As the funeral ended, his casket, draped with an American flag, rolled by us. I knew then that I needed to tell you about Marty.

Martin (Marty to most folks) was born in Portland, Oregon in 1931. He was a life-long Catholic and died at the significant age of 92. Today, as we ponder what scary events that we might have to endure, I am reminded of what he did live through! Born at the beginning of the Great Depression, he knew tight times. He was an Altar boy, defraying the cost of school at Central Catholic (\$50/year) in Portland. Like many young men who came of age in the 40's, 50's and 60's, Marty answered his country's call...as a US Army Paratrooper. I can't imagine that job! Afterwards, he met and married Jean. Their household added a daughter, Patti. After Jean's passing, Marty, Patti, and Randy joined forces, living in one home. Lucky Patti and Randy!

- Marty had been a professional meat cutter (Thanksgiving turkey carving duties. Check.)
- a Master Gardener (lawn ship-shape. Check.)
- a woodworker (many amazing birdhouses on display



after the funeral. Wow!)

- a doting grandfather to Jeremy and sister Ashley (always there for their games and graduations. Yup.)
- and an all-round GENEROUS man.

But wait! There's more! He volunteered at the Pittock Mansion museum in Portland's west hills. He water-skied at age 85 and he went to the gym into his 90's. Best of all, he was delightful to be around. Happy and humble. Always willing to lend a hand...especially to his family. He enjoyed life.

Back to the flag-draped coffin rolling past me at the church. Having just learned more about this man, I realized that Marty was willing to "answer the call" whether it was from his country, his neighbors and church, or his family. Marty's life was long and fairly "normal", yet his legacy is so impactful. Seems like he knew the value of a simple but intentional life. Fine example you are to us, Marty!

P.S. Marty missed meeting his new great-grandson by a few days. However, he was the only one who was told the baby's name before his birth!
