

Truth in Elections

Truth in Elections, Inc. began as the Election Integrity Team of Washington County (EIT-WashCo) in 2021 and has grown to nearly 60 vetted team members. Now a 501©4 non-profit organization, we are a grassroots, non-partisan group of citizens concerned about the state of our elections.

During the 2020 elections and the Covid-19 lockdowns, many of us observed the chaos around the country caused primarily by the nationwide shift to vote-by-mail. Realizing that our own state had been voting by mail for more than 20 years, we began to question the veracity of our voting system and decided to take a closer look.

For nearly three years, our team of citizen volunteers has donated thousands of personal hours and dollars to doggedly investigate our election system - from ballot design to election results. We filed many public records requests, conducted hours of research and observation, and obtained various records and documents that shook our confidence and led us to conclude that our election system needs a serious overhaul. We found vulnerabilities and anomalies that threaten election integrity in several different areas including: Voter Rolls, Vote-by-Mail, Voting Machines, Chain of Custody, Observation, Ballots and Ballot Printing, Signature Verification, and Legislation.

Since ours is a government of "We The People", we believe The People must be made aware of what we have found. While we could easily conduct a weekend seminar to inform others of our discoveries, we have developed a one-hour presentation to provide our fellow Washington County citizens with a general overview of findings from each topic area. Coupled with the presentation is a brief hand-

counting exercise demonstrating the efficacy of the system developed by Linda Rantz and used in Missouri to hand-count ballots.

We realize that the issues faced in Washington County are not limited to our county but are found statewide, so we would like to be a resource for others. One example of this is our participation in the Oregon Republican Party's Election Integrity Symposium on May 24, 2024, in Keizer. Another is the development of our website (currently under construction) where we will be able to share information.

NFRW Committee Report June 2024

The NFRW Advocacy Training Committee is one of a handful of special committees assembled by your NFRW President, Julie Harris. Our mission is to prepare information for NFRW leadership on given topics.

The Chair of this 12-woman group is none other than former three-time COFRW President, Deborah Tilden, now of Montana. Jann Hopkins is a committee member and formerly COFRW Secretary and Achievement Awards Chair. Jann and her husband now reside in Florida. I am Margie Crawford, COFRW member, and now the Secretary of this committee. Other women in the group are residents of Arizona, Indiana, Louisiana, Kansas, Arkansas, and Wisconsin. The group

includes women who are lawyers, judges, and State NFRW Presidents. With the urgency of the border crisis, we are meeting every week by Zoom.

In May, we had an amazing list of speakers including Clare Lopez, Founder of Lopez Liberty, LLC, Christie Hutcherson, Women Fighting for America, J.J. Carroll, retired 24-year Border Patrol Agent and author of Invaded, and our very own member and Oregon State Representative, Vikki Breese-Iverson, reporting about her recent trip to the Yuma Sector of the US Southern Border.

The topics that we originally were assigned included human trafficking, women's health and the Border crisis. Honestly, the latter has dominated our conversation and includes the other topics. Our federal government has failed to protect us at the **Southern Border**, yes,

but also the **Northern Border**, **East and West Coasts**, and the fifth border – **Digital**.

Tasks we are developing:

- A 30-minute video presentation in July on the Border for NFRW.
- A 10-point list of questions for members to use when interviewing candidates.
- A To-Do list for members like "Know your Sheriff"; understand the extent of human trafficking, sex trafficking, drug use, military threat, etc. caused by the millions of illegal aliens in our country; tools on how to reach your Legislators with questions.
